Hold Harmless Agreement - Company Certificate of Registration

Company Certification & Warrant

I hereby warrant and certify the following to the Motor Vehicle For-Hire Authority (the Authority) and to the participating municipalities of the Interlocal Agreement, Gulfport, Biloxi, and D'Iberville (the Municipalities) the following information pursuant to Article I, Section 5-Eof the Rules and Regulations adopted by the authority on February 11, 2016:

- (i.) That the Company, its officers, agents, drivers, employees, and contract employees have each received a copy of the Rules and Regulations adopted by the Motor Vehicle for Hire Authority on February 11, 2016 (referred to as Rules and Regulations herein).
- (ii.) That each vehicle and driver affiliated with its Company (whether by direct employment, contract, lease, or assignment) is in compliance with the Rules and Regulations set forth herein.
- (iii.) That each vehicle has been inspected in accordance with the requirements of these Rules and Regulations
- (iv.) That each vehicle is covered by a policy or policies of insurance in accordance with the requirements of these Rules and Regulations
- (v.) That the company has investigated the criminal background of each driver affiliated with its Company (whether by direct employment, contract, lease, or assignment) and that they have no affiliated driver whose criminal record revealed a violation of the items outlined in **Article II, Sec. 2** of the Rules and Regulations
- (vi.) That the company has investigated the driving history of each driver affiliated with its Company (whether by direct employment, contract, lease, or assignment), by and through the Department of Motor Vehicles for each state in which that driver has lived in the preceding three (3) years and that the company has no affiliated driver who's driving record revealed a driving history that includes a conviction, guilty plea, or plea of *nolo contendere* to any of the offenses outlined in **Article II, Sec. 2, paragraphs D and E** of the Rules and Regulations.
- (vii.) That each driver affiliated with its Company (whether by direct employment, contract, lease or assignment) meets the requirements for the issuance of Driver's permit outlined in **Article II, Sec. 2, paragraphs A-G** of the Rules and Regulations.
- (viii.) That each driver affiliated with its Company (whether by direct employment, contract, lease, or assignment) has been tested for the presence of illegal drugs or other substances by a drug screening facility approved by the Authority and that the Company has permitted no individual to drive a vehicle for hire within its control who has tested positive for the presence of illegal substances.
- (ix.) That the company periodically conducts random drug tests of its affiliated drivers; and, that in the event a driver tests positive for presence of illegal substances, that the company no longer permits that driver to drive or operate a vehicle for hire.
- (x.) The undersigned certifies that she or he has been duly authorized by the company to execute this document on its behalf and that, by the undersigned's signing below, the company has agreed to be bound by the certifications, warranties, and representations made herein.

Finally the undersigned acknowledges that the company is aware that the Rules and Regulations are from time to time amended and that the Company has a duty to keep abreast of any and all amendments and that it, its officers, agents, drivers, employees, and contract employees, are bound by any amendments upon the effective date of the amendment.
